#### Audits-General Fund Balance\*

- FYE 2023 \$5,481,915 = 9.4 Months of Annual Expenses
- FYE 2022 \$6,060,129 = 12.6 Months of Annual Expenses
- FYE 2021 \$5,471,268 = 10 Months of Annual Expenses
- FYE 2020 \$5,886,824 = 12.3 Months of Annual Expenses
- FYE 2019 \$5,661,132 = 13.8 Months of Annual Expenses

  - FYE 2021 = 141,808,508 (14,180.85 = 1 cent levy)

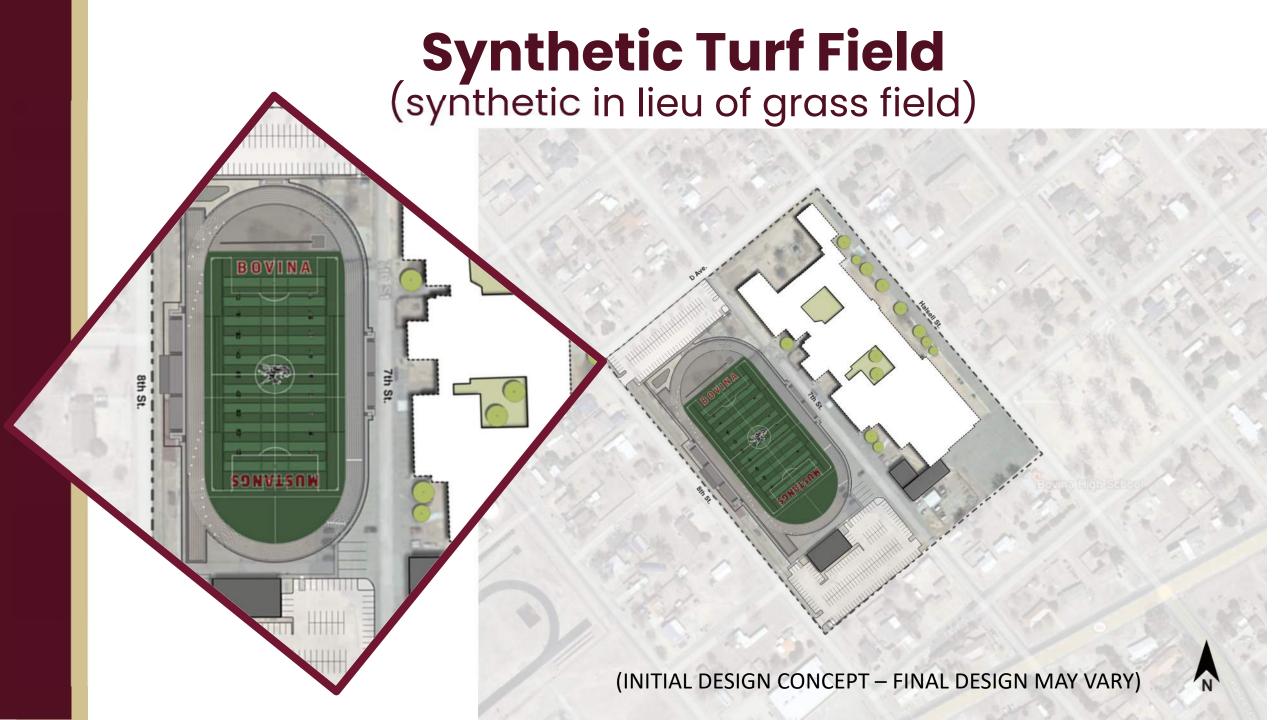


#### **Track & Field relocation to Main Campus** (grass field, new stadium seating, & parking)

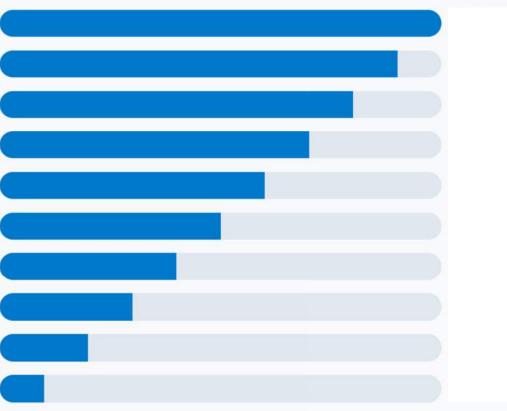
